Subject: Release of CBSE Handbooks for Teachers and Students

Dear Principals,

I begin with a belief that you have taken necessary measures for the discussions on and implementation of various Handbooks made available on the CBSE websites vide Circular no.17/2019 dated October 1, 2019.

It is expected that this handbook will answer most of the queries pertaining to the professional lives of teachers with regard to their association with CBSE.

[Handbook for Students](#): Students have so many questions related to pedagogy, subject choices, examination, CBSE activities, procedures etc. To address all their queries, CBSE has prepared the **Handbook for Students** containing details about the matters pertaining to academics, examination, personality enhancement activities, disaster management, cyber safety and other usual administrative procedures related to subject and date of birth change.
